## AGREEMENT

WHEREAS:

Courtenay Fellowship Baptist church is a non-profit society registered under the Laws of British Columbia (CFBC);

Courtenay Fellowship Baptist Church conducts a Summer Day Camp for children (CFBC);

The parent is the legal guardian and primary caregiver of the child/children listed (The Parent);

IN CONSIDERATION of the CFBC providing the program, property, equipment and supervision, CFBC and the parent agree as follows:

The parent consents to the child participation in the Summer Day Camp;

Summer Day Camp activities include:

singing, skits, sports, games, crafts, classes, hiking (woodland trails), and swimming (ocean/river), transportation to and from the various activities;

The parent confirms that the child does not suffer from any pre-existing mental, emotional or physical conditions, allergies or infirmity which would prevent or hinder the child's full and active participation in the various activities;

The parent waives, releases and forever discharges CFBC, its directors, employees, members, adherents, volunteers, agents and assigns from any and all claims, actions or suits brought on by or on behalf of any child for any loss or injury to person or property, including death resulting from or in consequence of having participated in the Summer Day Camp;

The parent grants to CFBC the authority to take whatever steps in it's absolute discretion deems reasonable and necessary in a medical or other emergency for the safety and well-being of the child;

The parent grants to CFBC the right to document the child's participation in the activities including: recordings, photographs, video-tapes and to retain such information for it's own non-commercial purposes;

The parent will complete the attached Registration document which, when completed, forms part of this agreement;

The parent is at liberty to seek legal advice regarding the terms of this agreement;

CFBC will exercise all due diligence in the planning, preparation and conduct of the Summer Day Camp;
